

In 2017, the state of Alaska's population has decreased for the first time in 29 years. In Sitka, the population (8,748) is the lowest since 2009 (8730), the high was in 1993 (9,083). Where are our fellow Sitkans moving to? In this edition of The Trends we will take a deeper look in to the migration in Sitka.

From 2010-2017, Juneau enticed the most Sitkans, followed by Anchorage. Overall, Sitkans moved to other southeast communities if they remained in Alaska.



Alaska Exchanges Most Movers with Close or Populous States


Yearly gross migration with Alaska by State, 2000-2016



In addition to proximity, Washington and Alaska share historical, cultural, and transportation links. Washington is the largest source of Alaska's incoming migrants by a small margin, and it's by far the most common destination for people leaving Alaska. About one in nine people who leave Alaska move to Washington. (AK Economic Trends, March 2018)

If the expected trend continues, Sitka's population will continue to decline, in fact we are already lower in 2017 at 8,748, than the projected population for 2020. The decline appears to have started earlier than anticipated.




SITKA AGING POPULATION

Sitka's population is not just declining, it is also an aging population. This can affect many facets of our community including housing needs, healthcare needs, city tax base, city services, school enrollment and associated funding and retail activity. Sitka's largest age group is now 40-64 years, in 1990 is was the 'baby bearing age group' of 20-39 years. This is not unique to just Sitka, Americans are living longer and are having fewer children. The aging of America has created a situation in which relatively fewer workers will be asked to support a growing retired population.


